When excise bills are not paid timely, additional fees and interest are charged. The collection of the overdue bill is transferred from the Town of Wakefield Tax Collector to the Deputy Collector. It is the Deputy's responsibility to collect excise bills that are overdue and on warrant.

Kelley and Ryan is the Deputy Collector for the Town of Wakefield. There are many collection sites throughout the state. You may go to any of their locations to pay the bill. We suggest you telephone prior to visiting to determine the exact amount owed.

ROUTE 24 TO ROUTE 123 EAST. FOLLOW ROUTE 123 TO MAIN STREET. TAKE A LEFT ONTO MAIN STREET THEN FIRST RIGHT. LEFT AT LIGHTS, THEN FIRST LEFT. COLLECTOR'S OFFICE LOCATED IN CITY HALL, 45 SCHOOL STREET, ROOM #B4
